Trimesters: APIC, CHS and HELI use a trimester model. This allows students to either study a full-time study load and take a study break (if they have enough time left on their CoE) or distribute their study load across the trimesters to reduce the study and financial burden each study period.

Payment Due Dates: after payment of the tuition deposit and in each following study period, APIC, CHS and HELI students have the opportunity to pay their fees in 4 instalments. This means that students who distribute their study load across the trimesters can make 12 small payments across the year.

Fees displayed are relevant to 2024 and are subject to annual review. Fees are based on a student's study load in each semester/term. Fees applicable as of 29 August 2024.
