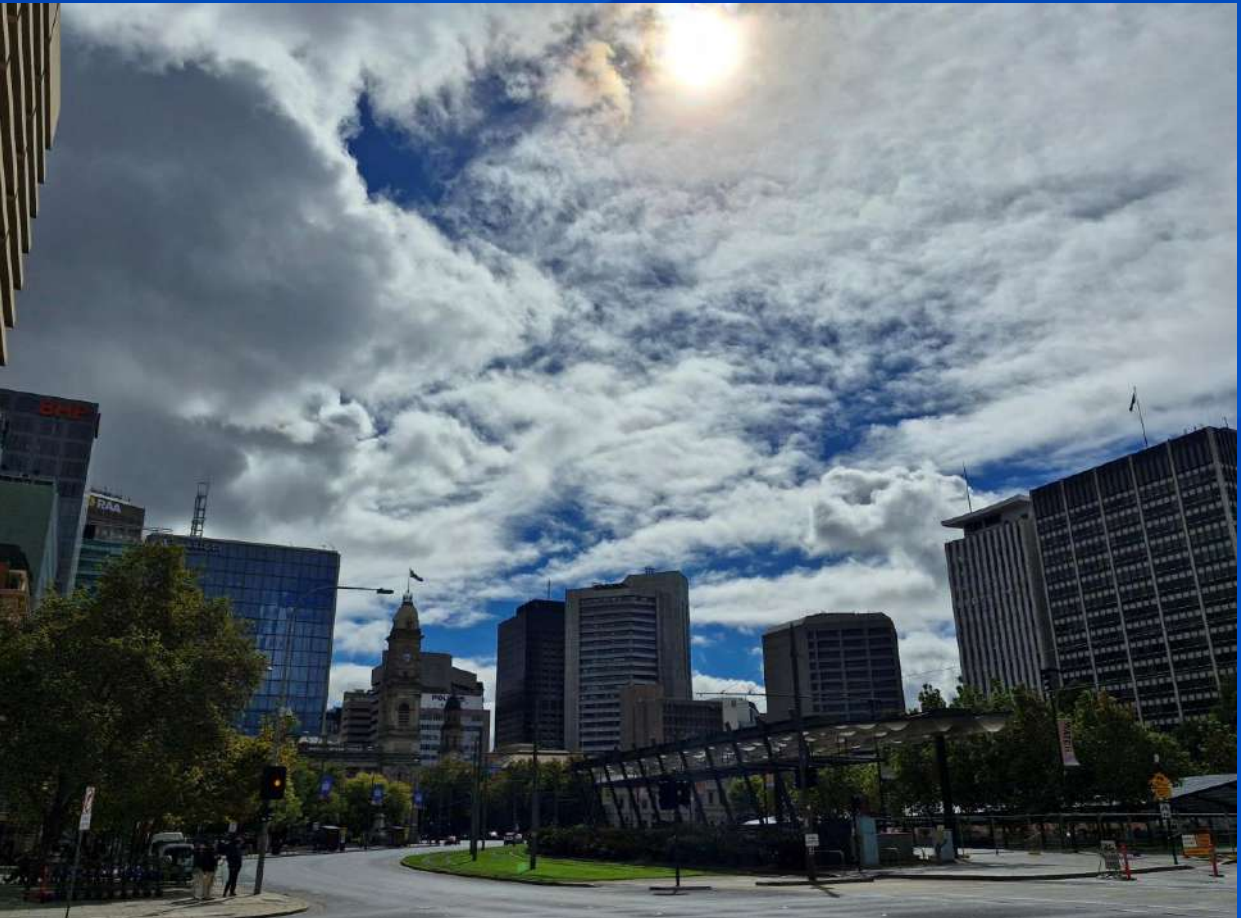
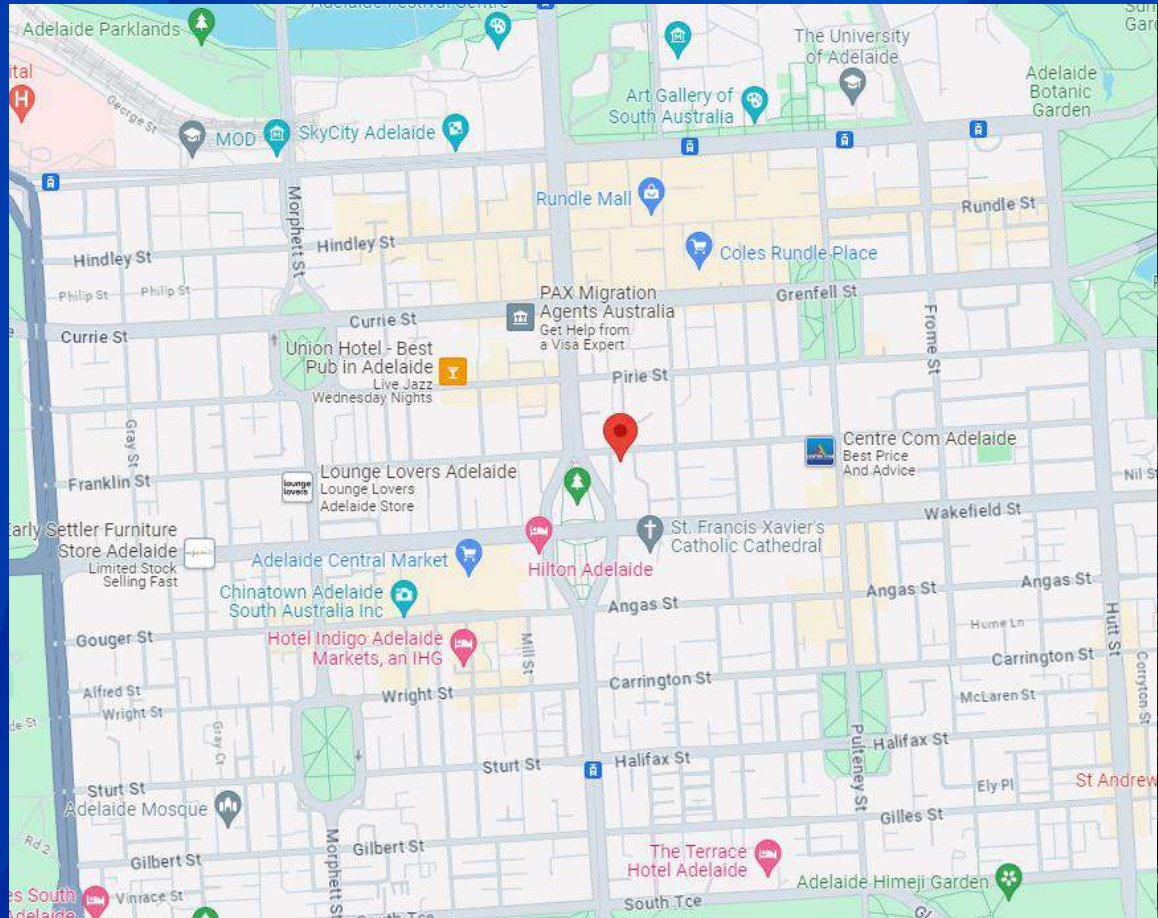

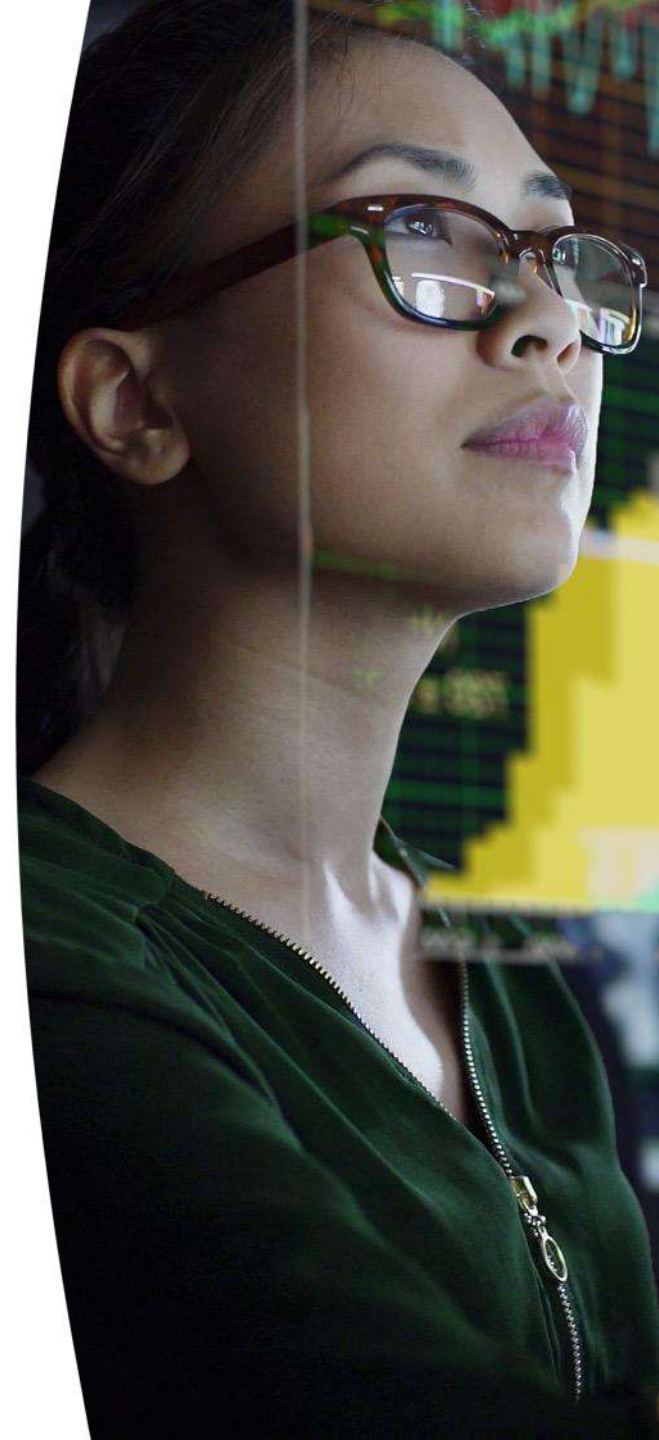

## South Australia Teaching Registration

Graduates with a three-year qualification can register with a condition on their South Australian teacher registration to teach in early childhood settings and lead in the provision of teacher-led, high-quality play-based education.

The amendment supports minimum qualification requirements for early childhood teachers holding an ACECQA approved qualification. It permits 3-year, Birth - 5 early childhood qualification holders to register with a condition on their registration. These new arrangements do not extend eligibility for teacher registration to holders of Graduate Diplomas and Graduate Certificates approved by ACECQA. The condition will limit 3-year early childhood trained teachers to teach in an early childhood setting, including pre-schools, kindergarten, early childhood learning centres, and in delivering education.

ACECQA supports the education and care sector by overseeing the National Quality Framework (NQF), which sets the minimum qualification requirements for educators working in early childhood settings.

An **ACECQA-approved qualification** ensures that graduates meet the necessary standards to work in family day care or centre-based services with preschool-aged children. In some cases, individuals can start working while actively working towards an approved qualification, making it a valuable step toward a career in early childhood education.

# Bachelor of Education Studies (Early Childhood) (0-5years)

## ACECQA Accreditation – Language proficiency

Individuals applying for a teaching qualification assessment under the National Quality Framework (NQF) must demonstrate proficiency in the English language.

ACECQA will accept the following as evidence of proficiency:

- **Study in an exempt country: One year of full-time** tertiary or higher education level study in either: **Australia**, New Zealand, Ireland, Canada, the United Kingdom or the United States of America.
- **Completion of a recognised English language proficiency test (undertaken in the last three years):**
  - International English Language Testing System (**IELTS**) test – **Academic version**: a score of seven (7.0) or more in the reading and writing components, and a score of eight (8.0) or more in the speaking and listening components, or
  - International Second Language Proficiency Ratings (**ISLPR**) – **Teacher-focused assessment**: Level 4 in all four skill areas of listening, speaking, reading and writing, undertaken at an approved testing site



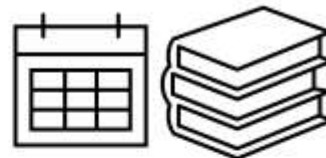

## Early Childhood Teacher (ECT)

ACECQA will accept the following as evidence of proficiency:

### Study in an exempt country:

- **One year of full-time** tertiary or higher education level study in either: Australia, New Zealand, Ireland, Canada, the United Kingdom or the United States of America.



### Completion of a recognised English language proficiency test (undertaken in the last three years):

- International English Language Testing System (**IELTS**) test – **Academic version**: a score of seven (7.0) or more in the reading and writing components, and a score of eight (8.0) or more in the speaking and listening components, or
- International Second Language Proficiency Ratings (**ISLPR**) – **Teacher-focused assessment**: Level 4 in all four skill areas of listening, speaking, reading and writing, undertaken at an approved testing site.



### Alternative evidence (contact ACECQA):

- On a case-by-case basis, ACECQA will consider evidence of a professional reference from an employer in either: Australia, New Zealand, Ireland, Canada, the United Kingdom or the United States of America.

# Bachelor of Education Studies (Early Childhood) (0-5years)

## Filling the early childhood workforce gaps

In South Australia, the shortage in early childhood education and care services is particularly acute. More than a quarter of services don't have a qualified teacher in a designated role. Regional and remote communities continue to face exacerbated workforce challenges..

The Government of South Australia is investing \$56 million in the early childhood education and care workforce. Initiatives will support attraction, qualification pathways, retention and quality.

## Creating a pipeline for more early childhood teachers and educators

The government is also moving to allow the registration of early childhood teachers holding a qualification recognised by Australian Children's Education and Care Quality Authority (ACECQA), including 3-year degrees, for teaching children aged birth to 5, to bring more existing teachers into the sector and allow specialisation in early childhood.

# Scholarships

At UniSC Adelaide, we offer a range of scholarship opportunities to our international students.

In addition to the scholarships listed on the right, international students should also check with their home institution and government to find out if other scholarship options are available to them.

## International Student Scholarship

The International Student Scholarship is a 15% tuition fee reduction offered to commencing international students in 2025.

## English Excellence Scholarship

The English Excellence Scholarship is a 20% tuition fee reduction that is awarded to commencing international students in 2025 who have achieved higher than required results in a recognised English language proficiency test.
