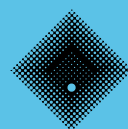


# REQUEST FOR FEE REFUND INTERNATIONAL STUDENTS



# VICTORIA UNIVERSITY

This form is for international students who are eligible to apply for a refund according to the [VU Fee Adjustment Procedure – Part D – Fee Refunds](#) and the [Tuition Fee Refund Eligibility criteria](#).

## Important Information

- VU Sydney & Brisbane student refund requests are processed according to the [VU Fee Adjustment Procedure – Part D – Fee Refunds](#)
- Refund applications will be processed within four (4) weeks from the date the fully completed form and supporting documentation is received. Incomplete forms or insufficient supporting documentation may cause processing delays in the refund process
- Your refund will not be processed until your course withdrawal is finalised\*.
- A student who is granted Leave of Absence or reduced study load will not be eligible to apply for a refund and will have any tuition fees paid held as a credit on their account and treated as a payment against future study periods.
- Refund applications must be lodged within 12 months of paying the fee or charge
- **Handwritten applications will NOT be accepted.**

\*Students who wish to apply for a refund after the commencement of their course must first have their enrolment formally discontinued. A student seeking a refund due to a course discontinuation but has not yet completed 6 months of study in the principal course (e.g., to transfer to another provider), must first apply for an International Student Release and obtain an approval outcome from the Student Administration team.

Students seeking a refund due to course discontinuation after completing 6 months of study of the principal course, they must first obtain a Course Discontinuation Approval Outcome from Student Administration.
